

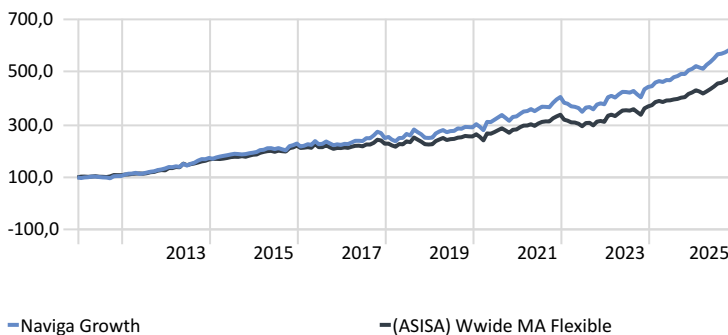
INVESTMENT OBJECTIVE

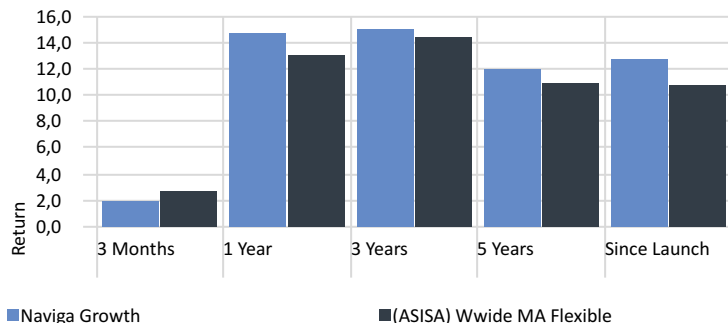

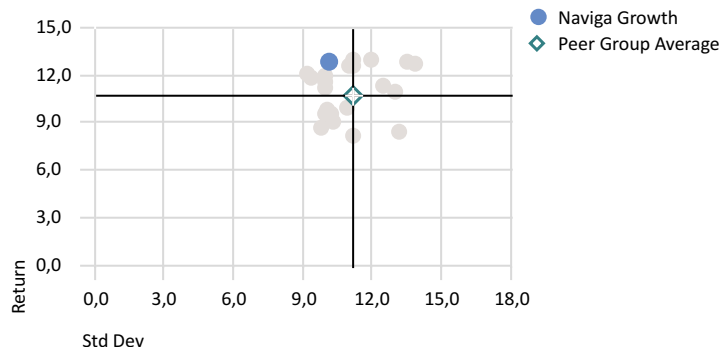

HIGH

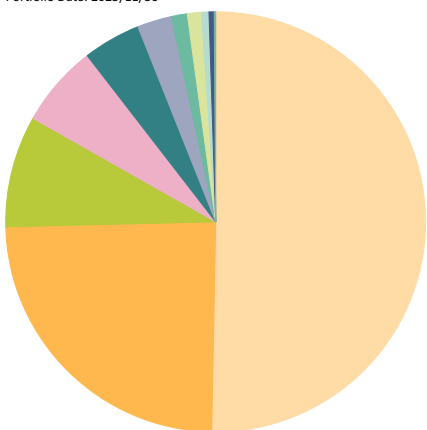

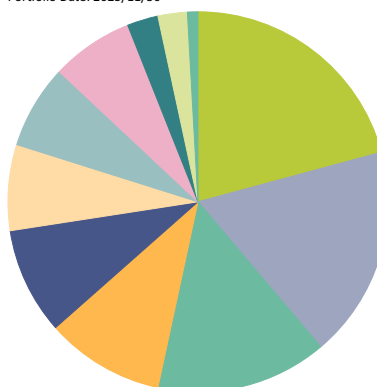
