

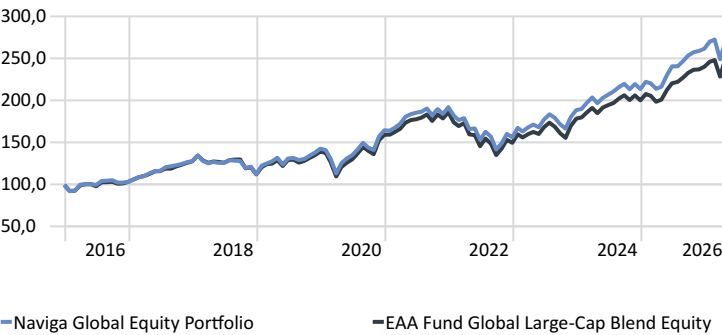
INVESTMENT OBJECTIVE

INVESTMENT GROWTH

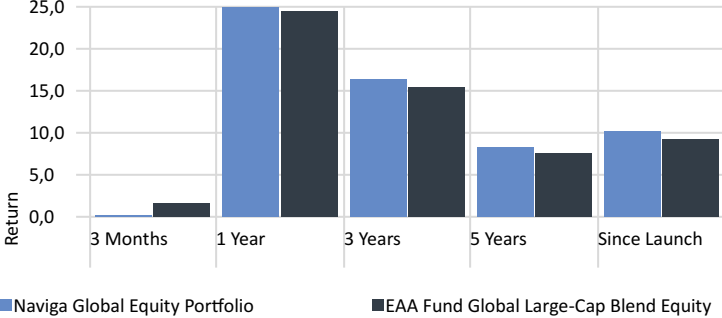

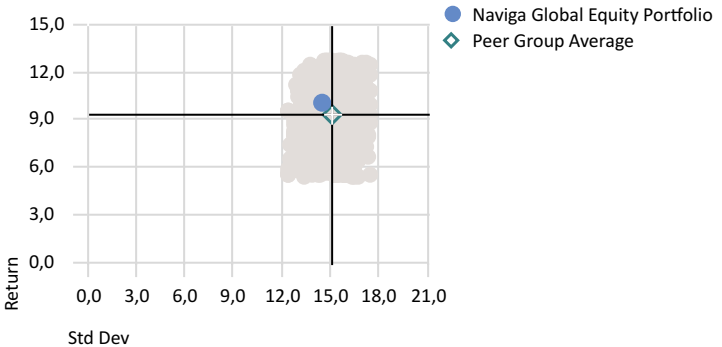

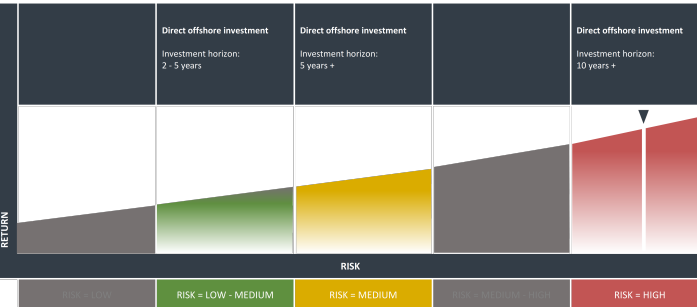

HIGH

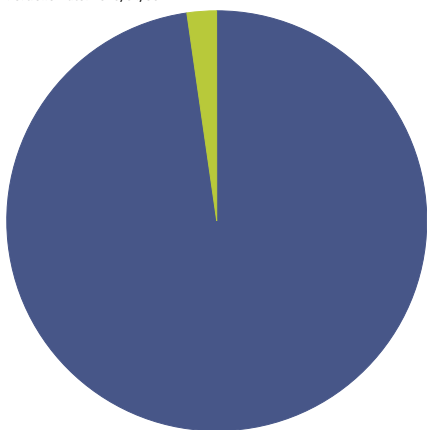

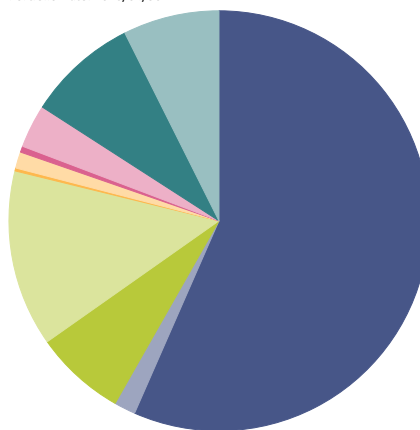
