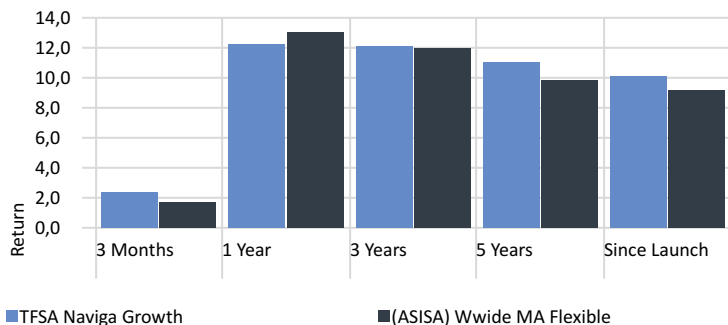

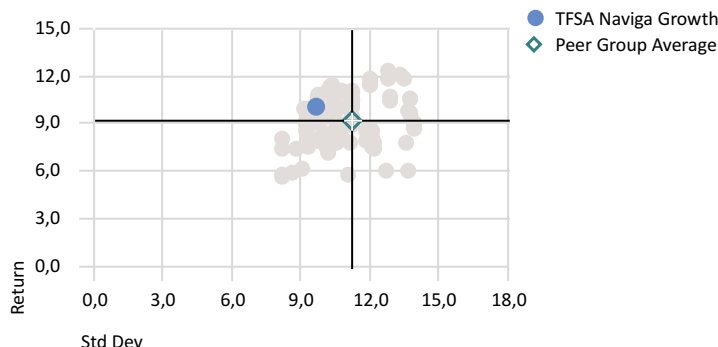

### HIGH

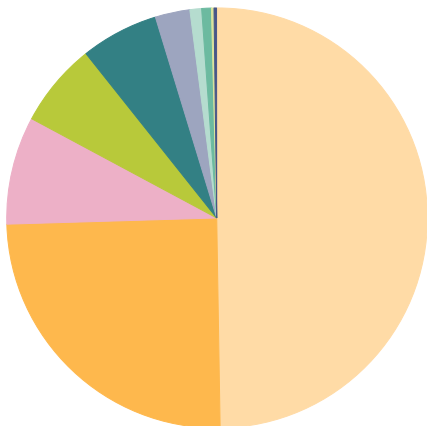
