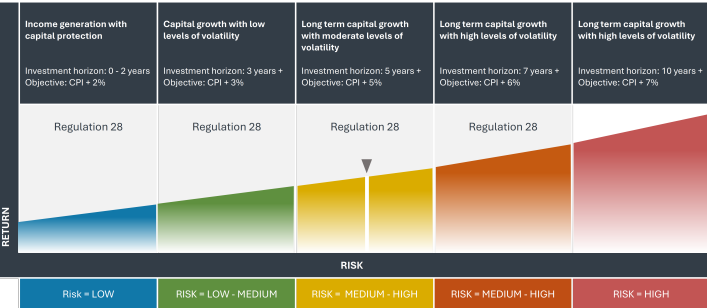

MEDIUM - HIGH

- However, the potential long-term investment returns from higher risk portfolios are expected to be higher than lower risk portfolios.

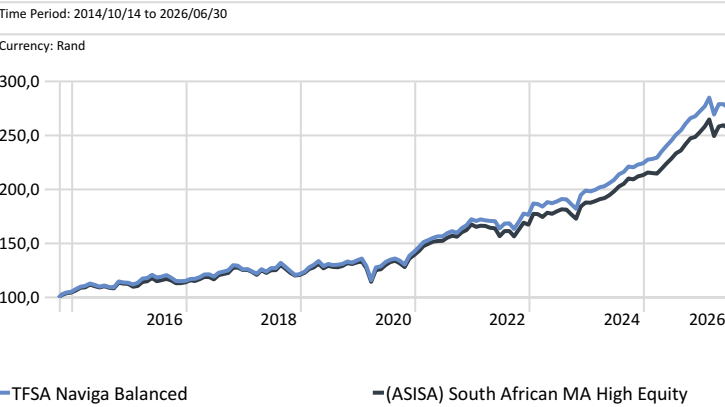

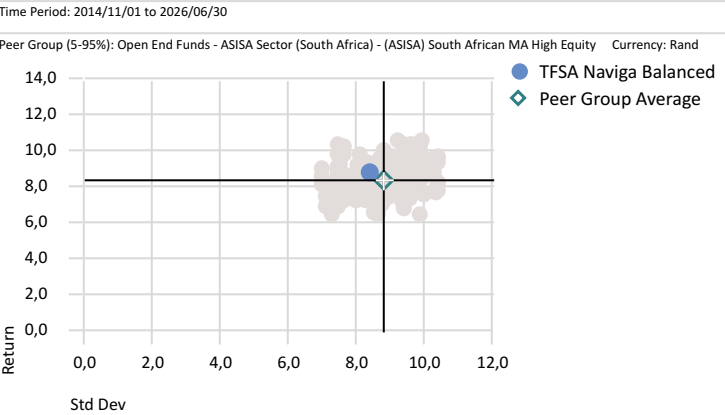

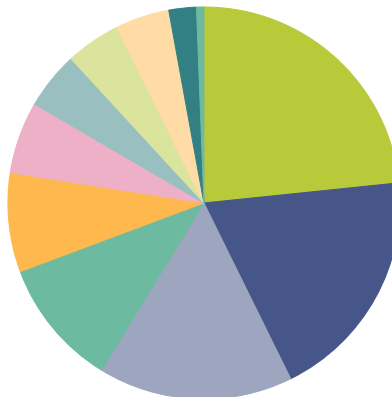
