

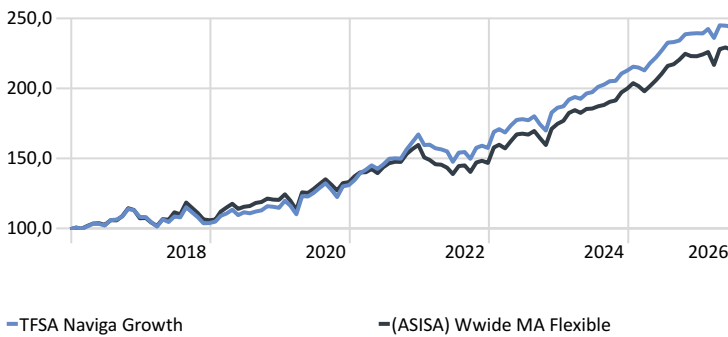
INVESTMENT OBJECTIVE

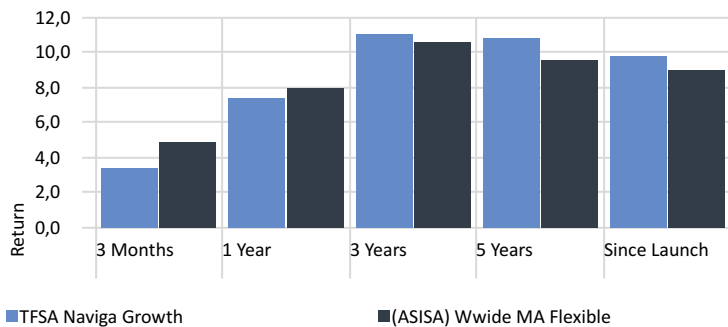

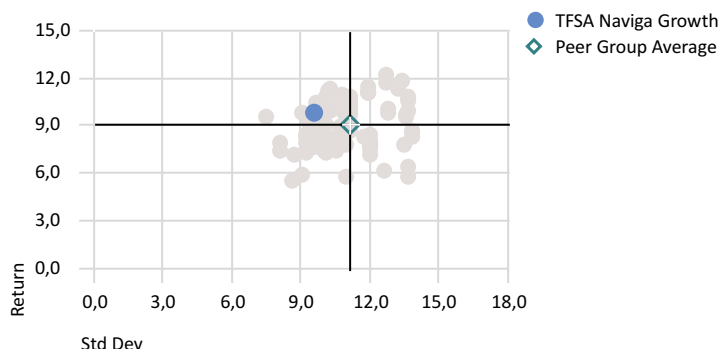

HIGH

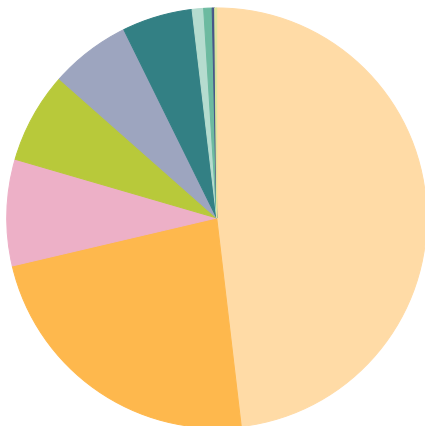
