

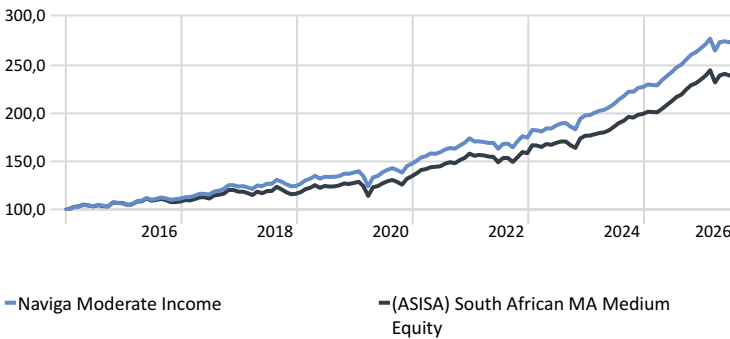
INVESTMENT OBJECTIVE

INVESTMENT GROWTH

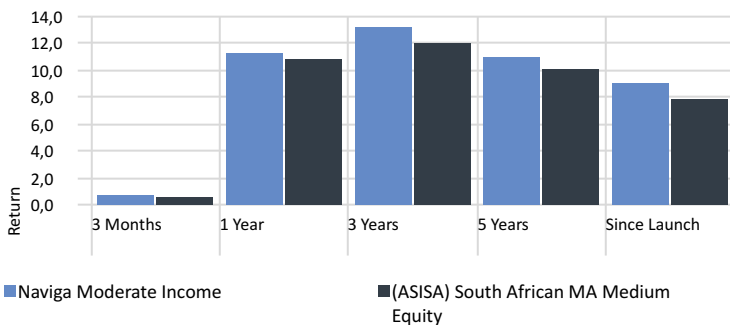

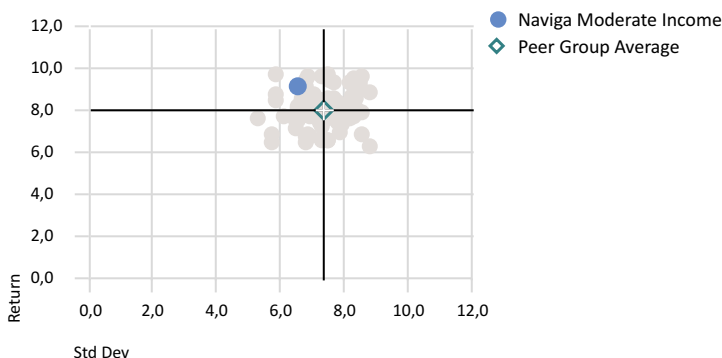

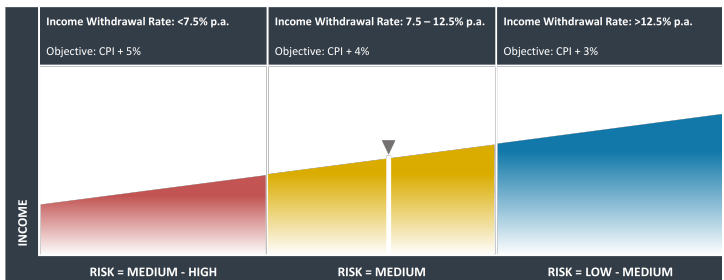

MEDIUM

- Medium risk portfolios generally have moderate levels of equity exposure, resulting in less volatility compared to portfolios with higher equity exposure, but higher volatility compared to portfolios with lower equity exposure.
- Moderate exposure to equity and other growth assets increases the probability of capital loss (permanent or temporary) compared to low-risk portfolios, but lowers the probability of capital loss compared to high-risk portfolios.
- The potential long-term investment returns from medium risk portfolios are expected to be lower than higher risk portfolios, but higher than lower risk portfolios.

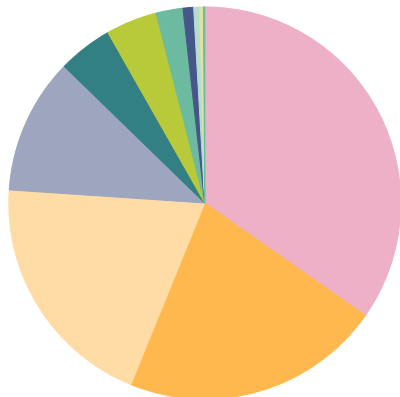

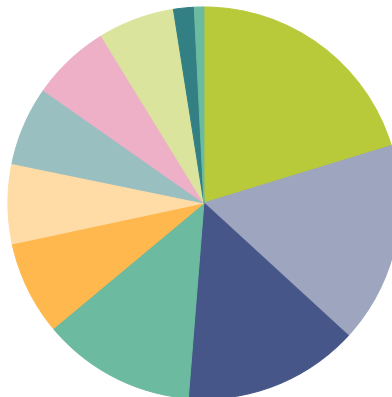
