

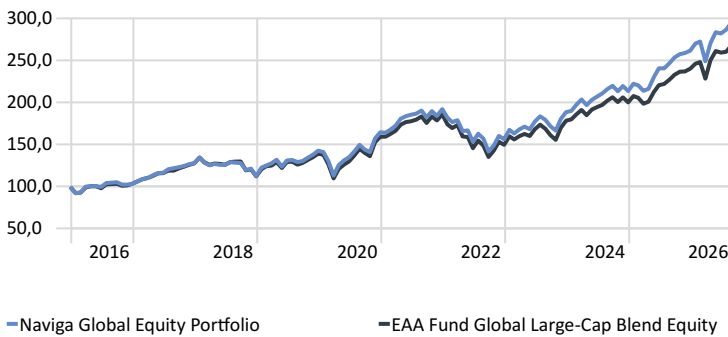
### INVESTMENT OBJECTIVE

### INVESTMENT GROWTH

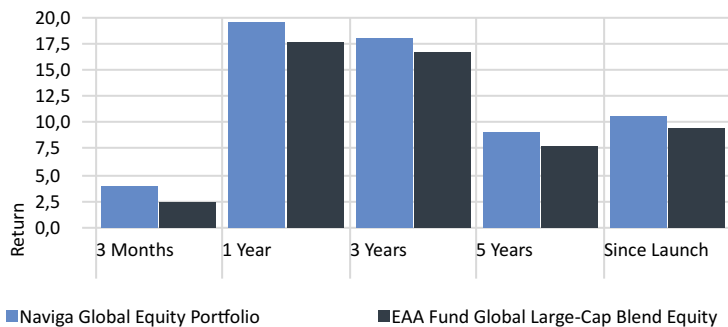

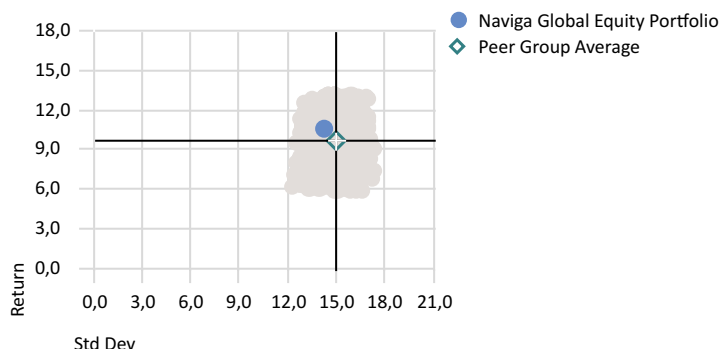

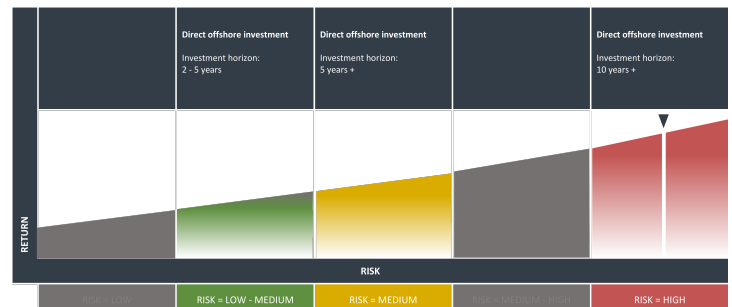

### HIGH

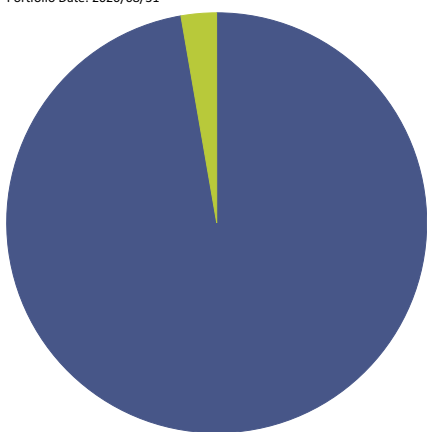

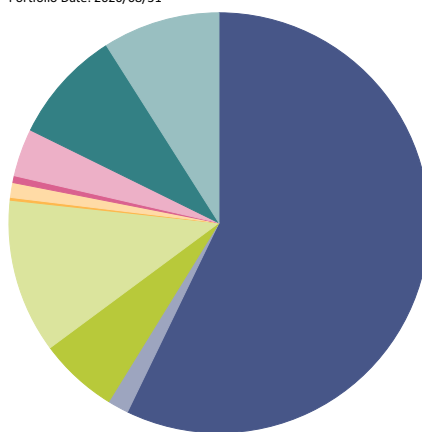
