

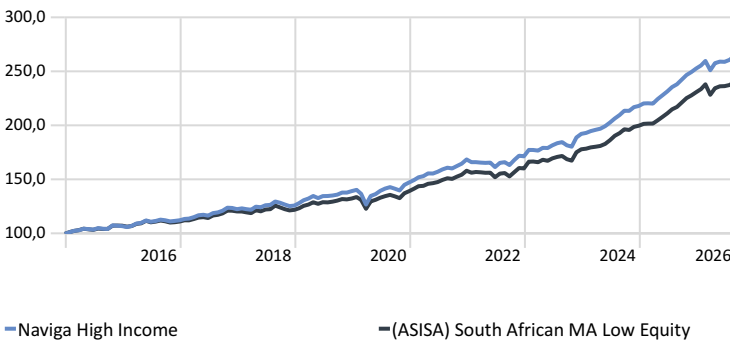
INVESTMENT OBJECTIVE

This portfolio is suitable for investors with a high income need. The primary investment objective is to provide income, with a secondary objective of capital growth over the long term, at low levels of volatility. The portfolio is divided into term components, allocating to income-generating funds in the short-term component for income provisions, while allocating to growth funds in the long-term component for capital appreciation. Due to the high income need, this portfolio has a bias towards income-generating funds. The portfolio will be rebalanced when markets are favourable.

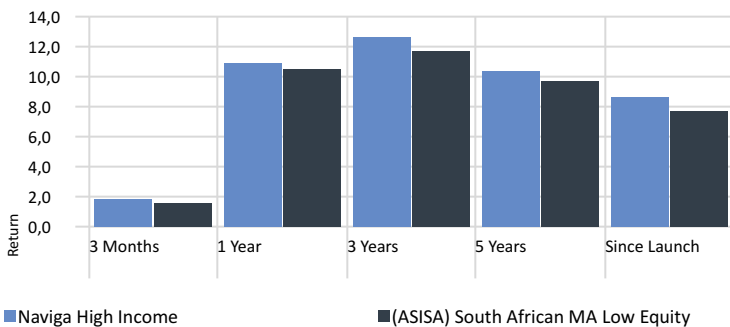

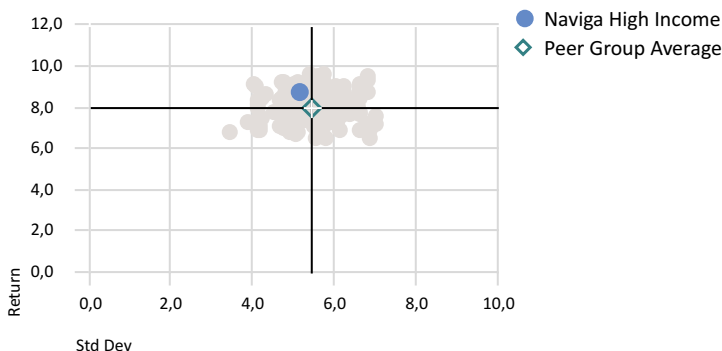

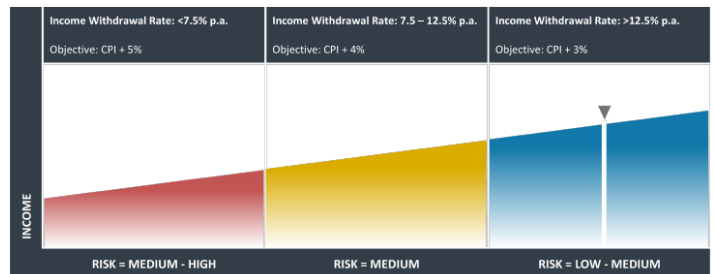

LOW - MEDIUM

- Low-medium risk portfolios generally have lower levels of equity exposure, resulting in lower volatility compared to portfolios with higher equity exposure.
- Lower exposure to equity and other growth assets also lowers the probability of capital loss (permanent or temporary) compared to higher risk portfolios.
- However, the potential long-term investment returns from lower risk portfolios are expected to be lower than higher risk portfolios.

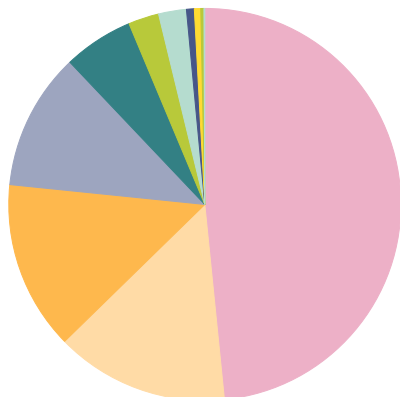

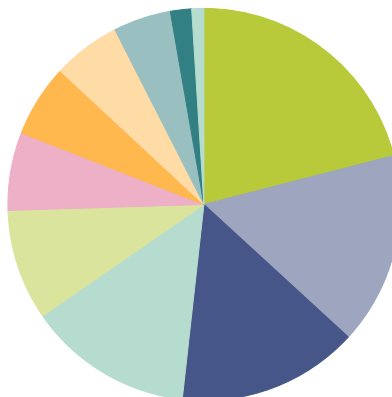
