

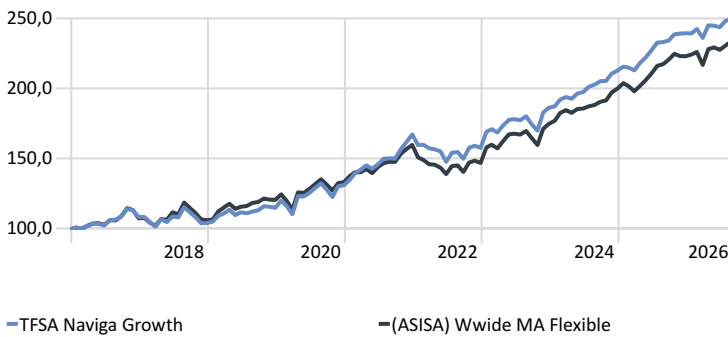
INVESTMENT OBJECTIVE

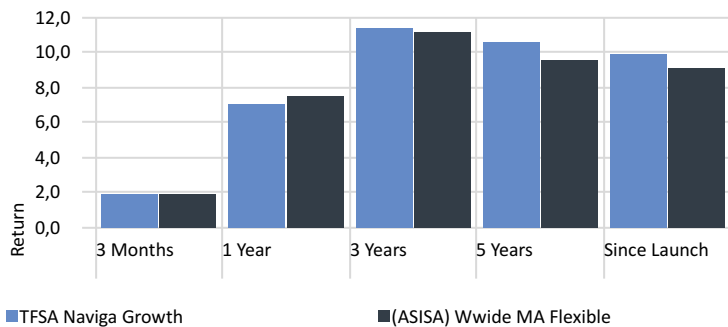

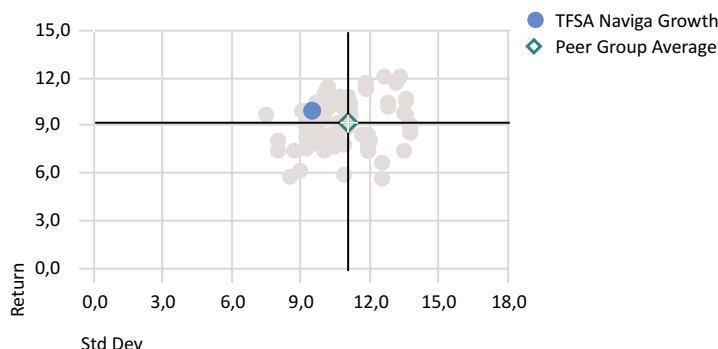

HIGH

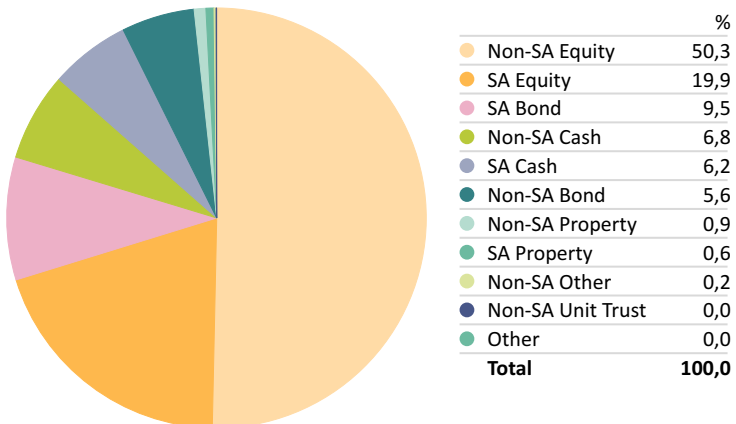

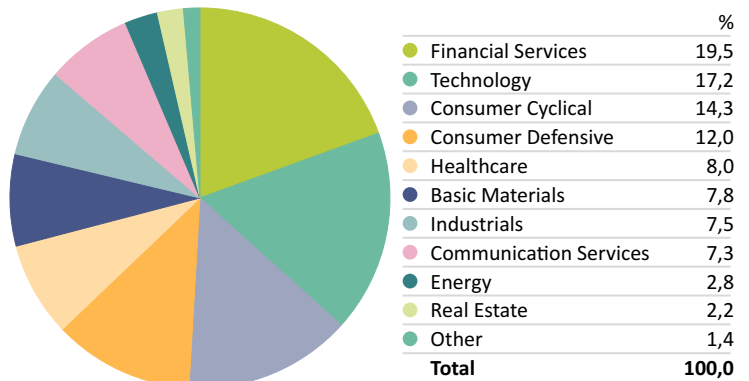
ASSET ALLOCATION
